PROOF OF ELIGIBILITY

US Citizen:

- Must have a valid US Drivers License
- Suspended or revoked must be eligible for reinstatement with an SR-22

Non US Citizen (Proof of Identity):

- Matricula, Passport, Foreign Drivers License, Expired TX Drivers License, Expired TX ID

DISCOUNTS

(applies in addition to transfer discount)

- Accident Free Renewal
- Paid in Full
- Driving Record
- Named Driver
(not subject to maximum discount limitations)

Transfer discount qualification is named insured provides at least six-months proof of prior insurance with continuous coverage with no more than a 30-day lapse in coverage.

- Any vehicle with a salvage title for Comp/Collision
- 1 ton vehicles or greater (*No Dually*)
- Excluded spouses
- Commercial use
